## 1. What is Workforce Development reimbursement?

Workforce Development reimbursement helps people get the technical training needed to work in energy efficiency-related positions.

The goal of the reimbursement is to provide financial support for technical training leading to a certification that will support the design and/or installation of measures or certifications required for projects within the New Construction Program.

# 2. Who is eligible?

If you meet any of these criteria, you're eligible for Workforce Development reimbursement.

- You live in the State of New Jersey; OR
- Your principal place of work is in New Jersey; OR
- You have another connection to New Jersey, such as being a New Jersey college or university student. This would have to be approved by the Program Manager and Board of Public Utilities staff, and proof of eligibility is required when you apply.

## 3. What does Workforce Development Reimbursement offer?

Applicants are eligible for a \$2,000 per person per course reimbursement, up to 100% of the total costs for the successful completion of a pre-approved training leading to a certification.

You can take two classes per fiscal year July 1 through June 30.

- You need to apply BEFORE you enroll in any training program. This will confirm eligibility for reimbursement.
- You must successfully complete the training to receive reimbursement. Successful
  completion means that you've passed the final examination or received the
  certification.

# 5. How do I get my reimbursement?

There are a few steps to follow to be sure everything goes smoothly.

1. **Before** you register for any training, you must apply and receive approval. This will confirm eligibility for reimbursement.

- 2. Once you receive your approval, register and pay for your training.
- 3. Attend all your required classes and pass your final exam.
- 4. Submit proof that you have attended all required classes and passed your final exam and/or received your certification. Submit receipts showing the total amount that you're asking to be reimbursed. Receipts must match the preapproved amount requested.
- 5. In 6 8 weeks, you'll receive your reimbursement, up to \$2,000 or 100% of the cost of the training, whichever is less.

Workforce Development reimbursement covers the cost of training and examinations for certifications. Any fees from a sanctioning organization (for example, to pay for membership or a certificate) are your responsibility.

## 6. What do I do next?
