### STAKEHOLDER MEETING

#### IN THE MATTER OF THE IMPLEMENTATION OF P.L. 2018, C. 17, THE NEW JERSEY CLEAN ENERGY ACT OF 2018, REGARDING THE THIRD TRIENNIUM OF ENERGY EFFICIENCY AND PEAK DEMAND REDUCTION PROGRAMS

Staff ("Staff") of the New Jersey Board of Public Utilities ("NJBP" or "Board") hereby gives notice and invites all interested parties and members of the public to participate in a hybrid stakeholder meeting to discuss the upcoming third three (3)-year period of the State's energy efficiency ("EE") and peak demand reduction ("PDR") programs pursuant to the Clean Energy Act of 2018 ("CEA"), L. 2018, c. 17 ("Triennium 3" or "T3"). The Triennium 3 programs will be administered by the Board and New Jersey's investor-owned electric and gas utilities and over the period July 1, 2027 to June 30, 2030. Staff is currently developing recommendations for Triennium 3.

This stakeholder meeting aims to convene a broad set of market actors and interested parties to share their vision for Triennium 3 and solicit specific input regarding key elements being considered for Triennium 3 as a result of developments following the first and second set of three (3)-year EE and PDR programs conducted pursuant to the CEA. The event, scheduled for July 14 and July 15 will include 1.5 days of structured facilitated sessions for stakeholder input, presentations of the key takeaways from breakout room discussions to the full group of participants, and networking opportunities. Stakeholders can expect to hear from keynote speakers and State energy leaders who will offer guidance on the role of T3 within a broader policy context.

Stakeholders will have the opportunity to provide input regarding energy affordability, cost containment, programmatic focus areas, involvement of upstream and midstream actors, and market expectations for a "one stop shop:" a single online destination for energy customers to quickly access comprehensive information on EE program offerings. For those who desire a role in defining the future of EE, demand response, and building decarbonization, this event provides a unique opportunity.
